.UK DOMAIN DISPUTE RESOLUTION 2023

Our Dispute Resolution Service (DRS) offers an efficient and transparent method of resolving disputes relating to .UK domain names.

The DRS seeks to settle disputes through mediation and, where this is not possible, through an independent expert decision.



NOTEWORTHY CASES THIS YEAR

EXANTE.CO.UK

The complainant was XNT Ltd., a company based in Malta offering financial and investment services. The respondent was The Hut.com Ltd, namely its brand of diet foodstuffs which had trademarks registered in 2007 and 2013 on the brands Exante and Exante Diet.

The Complainants claimed the domain in question was used in a manner unfair to them and that they didn't grant the Respondent any licence, or other authority, to use their trademark. The Complainants made allegations of bad faith and unfair disruption of its business against the Respondent, which were not properly supported by evidence.

The Expert was not persuaded, under the balance of probabilities, that bad faith could be attributed to the Respondent as their trademarks predate the Complaints. In fact, the Expert concluded that the case was brought forward by the Complainants in bad faith and a finding of Reverse Domain Name Hijacking was made.


GENERALELECTRICCOMPANY.CO.UK

The Complainant was General Electric Company (GE), originally set up as a merger between Thomas-Houston Electric Company and Thomas Edisons, Edison General Electric Company in 1892. The Respondent was IEA Global SAP Consultants - General Electric Company Ltd, established in June 2020. The Respondent decided to register a match to an existing US company so old that it was set up by Thomas Edison himself – what you might call a 'lightbulb moment' in a case.


The Expert poses the question raised in the DRS Policy: Can an overseas right constitute a relevant right within the definition of Rights? In this case the Expert believed so. The Expert states there is likely to be Initial Interest Confusion between the two General Electric Companies and awarded the domain name to the Complainants.

GEOGRAPHICAL DISTRIBUTION OF COMPLAINANTS AND RESPONDENTS



Nominet's Dispute Resolution Service has addressed over 13,000 .UK domain disputes since being established in 2001. To make a complaint through the DRS, you need to have rights (such as a trade mark) in a name which is the same or similar to the domain name you are concerned about. The DRS can usually provide a quicker and cheaper resolution to disputes than going through the courts as this service is based on free, confidential mediation. In the event of deadlock, complainants can pay to appoint independent experts from a panel to make a binding adjudication. Nominet does not profit from running the DRS, the fee for decisions is paid to the Expert for their time adjudicating disputes.
