The elections were conducted in accordance with the Nominet Articles of Association. Members had been asked to indicate if they would accept notification of the ballot by email, and where they did an email was sent giving details of the link to vote on a secure web system. Ballot papers were sent to those members in the post who had indicated their preference for paper versions. Ballot papers were returned in the post to Popularis, through the Popularis web voting system or directly at the AGM on 2nd June 2015.

The web voting system was accessed via a Popularis 'landing page'. It was held on a server independent from Nominet, and the requirements for a secret ballot were observed regardless of the method used to return a ballot paper.

All systems were checked to ensure no member voted more than once by using more than one system to return their votes.
