The Chair has confirmed that following a formal performance evaluation, Andrew's performance continues to be effective and demonstrates his ongoing commitment to the role.

*Non-Executive Director*

Andrew was appointed to the Board in July 2015 and has a long and distinguished career in both the private and public sectors. He is the Chairman of Digital Mobile Spectrum Limited (DMSL), Market Operator Services Limited and Finnergy Limited and is also a non-executive director of Silent Circle LLC.

After 18 years in the Inland Revenue, where he became Director of IT, Andrew moved to the private sector, becoming Director of Operations and Technology at Prudential Corporation before joining Citibank Investment Bank as Head of European Operations and Technology. In 2000 Andrew was appointed as e-Envoy by the then Prime Minister, Tony Blair and was awarded a CBE in 2004. Since 2004 Andrew has been Chairman or non-executive director of numerous boards, making him a highly experienced board member.

Andrew is currently a member of the Audit and Governance and Remuneration Committees. Subject to being re-appointed, he would become Chair of the Remuneration Committee and also take on the role of Senior Independent Director.

Following the resignation of Oliver Hope as a non-executive director in June 2015 and in accordance with Article 31 the Board appointed Jane Tozer to fill the elected director vacancy until the end of the next AGM. Following a formal performance review that confirmed Jane's performance to be effective and demonstrated her ongoing commitment to the role, the Board agreed in January 2016 to propose that Jane be re-appointed as an Appointed Director by way of an Ordinary Resolution of the Members at this AGM.

Jane was appointed to the Board in August 2015. She is an experienced non-executive with a current portfolio including StatPro plc, F&C Global Smallers plc, JPMorgan Income & Growth plc, Asthma UK and Three Rivers' Citizen's Advice Bureau.

Jane has a strong technology background, after starting her career at IBM she became CEO of a software house and has served as a director of a variety of quoted, private, and public sector businesses. She was awarded an MBE for services to the IT sector in 1991, and an OBE for services to the public service and voluntary sectors in 2009.
